

## Mt. Haven Annual Meeting 2024

held on June 3rd at Brighton Fire Station  
from 6:30 PM to 8:00 PM

### Water Master, Steve Macintosh

#### Update:

- Water is working really well
- Opened on May 9th, followed by filling, testing, telemetry
- Currently running at 33 gal/min
  - o comparable to 2022 (2023 was an exceptional high-water year)
  - o In the winter, the spring runs around 15 gal/min
- Steel water tank placed in 1968, last inspected 5 years ago
  - o Liner is gone but holding water OK. If community tanks need to be expanded we may consider replacing the current ones.
- Cost this year: Sensory caps replaced on telemetry, new chlorinator pump
- 4 water tests required, all passed
- Regular monitoring per state requirement: 3 tests per week
- Annual cost for neighborhood water paid to SLC: \$16K (5% increase per year)

#### Filling tanks:

- Per Utah Division of Drinking Water (DDW), there is a source deficiency (from spring) and storage deficiency (neighborhood tank) based on projected household usage in the valley
- Steve is in the final year of 3-year data collection re: neighborhood usage in order to demonstrate that Mt. Haven usage is much lower and no deficiency exists
- WHAT WE NEED TO DO
  - o Reduce winter tank filling to 2 gal/min
    - this will cut flow rate down by half, so we can prove there is enough source water. *Details to follow when we send out the tank filling schedule.*
  - o If you need to use a heavy amount of water for whatever reason for a brief period, please text Steve to notify (801-330-3448) – Please communicate more than necessary

### Treasurer, Coleman

#### Update:

- HOA fund grew in money market
- Initiated Zelle for HOA payments
- HOA fees have remained flat despite increasing costs. Will likely increase next year to account for rising water cost
- i.e. Gate repair 2023: \$7K
- Emergency fund remains adequate, 3K deposit/year

SAVING MONEY via volunteer work

- Neighborhood road repair day June 1
- Weekly water testing

## **President, Kevin**

Update:

- Generally a 'simple year' – no major catastrophes, road quality is stable
- RMP will continue burying powerlines, commencing this year or next
- They have been surveying the neighborhood this season

Changing by-laws to regulate long term rental agreements:

- We will set up a community vote to update the by-laws to current community needs

*More details to follow.*

- Currently no short-term rentals per Town of Brighton
- Long term rentals must use neighborhood rental agreement. Thus far, we have had good experiences with long term renters who engage with the community
